I acknowledge the inherent risks, including but not limited to scratches, bites, allergic reactions, slips, falls, and exposure to art materials.

**4. Parental Consent**

I give permission for the above-named minor to participate in all activities associated with Paint and Paws LLC events.

**5. Assumption of Risk**

I knowingly and voluntarily assume all risks on behalf of the minor, both known and unknown, associated with participation in these activities.

**6. Release of Liability**

**7. Animal Interaction Agreement**

- Follow all handler and staff instructions
- Interact with animals only when permitted
- Avoid sudden or aggressive behavior
- Not feeding animals unless instructed to do so
- Not hold animals while standing in an upright position, only while sitting
- Not disrespecting the animals

### **Animal Interaction Agreement**

- Avoiding aggressive, sudden, or rough movements around animals
- Always respecting all handlers and staff guidance
